**TERMS**

Ten percent late charges on unpaid balance after 20 days.

\$20.00 service charge on all returned checks.

Disconnection after approximately 45 days on unpaid balances with a \$50.00 trip charge.

**IMPACT FEES**

Once it has been determined that water and/or sewer service is available to your property, a fixture rate sheet should be completed, and confirmed by our Engineering Department before the payment of impact fees are made. The fixture value worksheet determines the amount of impact fees due and monthly charges. Monthly charges are calculated in quarter increments.

Rates are subject to increase March 1 of each calendar year.
